the sum of 7,128,450 dollars to be levied as a special tax for operations and maintenance purposes; and
the sum of 2,852,000 dollars to be levied as a special tax for transportation purposes; and
the sum of 0 dollars to be levied as a special tax for a working cash fund; and
the sum of 2,700,000 dollars to be levied as a special tax for municipal retirement purposes; and
the sum of 2,800,000 dollars to be levied as a special tax for social security purposes; and
the sum of 713,000 dollars to be levied as a special tax for fire prevention, safety, energy conservation, disabled accessibility, school security and specified repair purposes; and
the sum of 6,000,000 dollars to be levied as a special tax for tort immunity purposes; and
the sum of 570,275 dollars to be levied as a special tax for special education purposes; and
the sum of 713,000 dollars to be levied as a special tax for leasing of educational facilities or computer technology or both, and temporary relocation expense purposes; and
the sum of 7,280,667 dollars to be levied as a special tax for Bond and Interest; and
the sum of 7,994,734 dollars to be levied as a special tax for PBC Lease
on the taxable property of our school district for the year 2010.
